

It is with immense appreciation for our collective efforts that I present the 2024 Annual Report of the National Union of Disabled Persons of Uganda (NUDIPU). Our journey this past year has

been powered by our shared commitment to advocacy, capacity building, research, resource mobilization, gender mainstreaming, networking, and economic empowerment, all converging towards our fundamental vision: a just

Our collective achievements in 2024 include expanding access to ICT and digital skills for PWDs through vital initiatives like the Inclusive ICT Initiative and the Online Observatory, championed by the UCC. These programs are building bridges across the digital divide, fostering greater social and economic participation. The success of our iSAVE program, in collaboration








2024 ORGANIZATIONAL YEAR

OVERALL BENEFICIARY REACH

In 2024, NUDIPU'S programs reached 31,973 Persons with Disabilities through its various interventions, comprising 13,553 males and 18,420 females. This milestone underscores the program's deliberate and inclusive approach, with a strong emphasis on addressing the unique needs and challenges faced by Persons with disabilities. The extensive community coverage and gender- responsive design reflect a firm commitment to leaving no one behind and ensuring equitable access to services, resources, and opportunities for all Persons with Disabilities

CAPACITY STRENGTHENING OF OUR MEMBER ORGANIZATIONS TO DELIVER AND STAKEHOLDERS ON DISABILITY INCLUSION

NUDIPU strategically prioritizes capacity strengthening for its member organizations, including district unions of persons with disabilities, to enhance their expertise in disability-inclusive programming and service delivery. Furthermore, NUDIPU proactively seeks opportunities to develop the capabilities of its staff and board, thereby maximizing its effectiveness in fulfilling its mandate. Recognizing advocacy as a core organizational objective, NUDIPU also cultivates capacity among stakeholders to advance disability inclusion and delivery.

During annual year 2024, over 5,435 individuals were trained through various capacity-building initiatives aimed at promoting disability inclusion, governance, livelihoods, education, and community development.

From Neglect to Recognition: How NUDIPU is Transforming the Lives of Inmates with Disabilities

n Uganda, despite ratifying the CRPD in 2008, inmates with disabilities faced significant challenges within the prison system. Recognizing this gap, NUDIPU conducted a situational assessment in 2023 across four prison units including Luzira Murchison Bay prison unit, Luzira Upper prison unit, Luzira Women prison unit and Kitalya Minimax prison unit, revealing issues like a lack of leadership for inmates with disabilities, negative attitudes, inaccessibility, and a lack of special attention. Following this, the Uganda Prison Service requested NUDIPU to produce a national situational report, further assessment which highlighted these problems. NUDIPU then partnered with the Prison Service to provide capacity-building training on disability inclusion for inmates with disabilities, ward leaders, and prison staff in the same four units.

Follow-up visits by NUDIPU in November 2024 showed significant positive changes: the establishment of disability leadership structures with recognition, improved relationships between ward leaders and disability leaders with sensitization efforts, regular welfare meetings for inmates with disabilities, and exemptions from certain routines like lining up for phone calls or sun exposure for those with albinism. Accessible accommodation was also being prioritized.

These improvements, aligning with Uganda's constitutional and legal provisions for affirmative action, are directly attributed to NUDIPU's dedicated efforts.

"Enhancing Inclusion: Improving Access to the Parish Development Model for Persons with Disabilities"

s stipulated in the PDM guidelines, 10% of the program's funds are allocated to persons with disabilities. The PDM was introduced by the Government of Uganda to drive socio-economic acknowledged the validity of the concerns raised and made several commitments to address them. The Commercial Officer pledged to:



Provide 31 application forms to representatives of Persons

with disabilities for duplication and distribution;

- Invite the representatives to participate in SACCO meetings; and
- Translate the application forms into the local language to enhance accessibility and comprehension.

By the end of 2024, the Commercial Officer reported that 750 persons with disabilities had received PDM

funds - amounting to 5% of the intended beneficiaries. Each recipient was granted 1,000,000 Uganda Shillings to invest in an enterprise of their choice. This marked a significant milestone in improving access to economic support for PWDs. In addition, 1,023 individual Persons with disabilities benefited from Emyooga funds-an interest government initiative-receiving between 1,000,000 and 3,000,000 Uganda Shillings each. The project's engagement in advocating for equitable access to the PDM played a vital role in enabling persons with disabilities to secure long-needed financial support for their enterprises-support that had previously been inaccessible.

Under policy and rights department, NUDIPU engaged with persons with disabilities to assess the accessibility of PDM. Several barriers were identified, including lack of national identification cards, exclusion from enterprise groups, sale of application forms by parish chiefs - making them unaffordable— and corruption, where some Persons with disabilities were underpaid or defrauded by officials. In response, NUDIPU convened a dialogue meeting involving representatives of Persons with disabilities on PDM committees, Commercial Officers, and Parish Chiefs. Stakeholders

INCLUSIVE EDUCATION ADVOCACY EFFORTS





- The enrolment of learners with disabilities in our target primary and secondary schools increased from 1,509 in 2019 to 1,856 in 2024
- The number of Primary 7 candidates with disabilities that registered for Primary Leaving Examinations (PLE) rose from 1,128 to 3,328
- The number of teachers trained from our target schools that had adopted development of inclusive education plans for learners with disabilities increased from 22.2% to 39%.
- We observed enhanced collaboration between schools and policymakers in the education sector towards pushing the agenda of education of learners with disabilities

RESPONDINDING TO DISASTER: Disability Inclusive Disaster Risk Reduction (DIDRR)

DIDRR enhanced protection for people with disabilities (PWDs) during disasters and humanitarian emergencies in Bududa, Isingiro, and Kasese districts. The project empowered Disabled People's Organizations (DPOs) to spearhead inclusive DRR and humanitarian responses and increase awareness among duty bearers and mainstream actors about PWDs' unique risks and contributions.


- All three districts (Bududa, Isingiro, and Kasese) maintained disability representation in DRR planning, including MOUs and contingency plans.
- All District Unions now operate with clear work plans, supported by capacitybuilding initiatives.

SOCIAL AND ECONOMIC EMPOWERMENT OF PERSONS WITH DISABILITIES

Key achievements in 2024 due to our Social and Economic Empowerment efforts.

- Established 212 inclusive iSAVE groups, empowering 7,318 members through savings and financial literacy initiatives
- Collectively, these iSAVE groups saved UGX 593 billion, with UGX 72.67 billion disbursed as loans to support income generation and improve household wellbeing.
- Empowered 346 youth with disabilities through vocational training, skills development, and provision of start-up kits, enabling them to launch businesses and achieve self-sufficiency.
- Facilitated linkages for 151 Persons with Disabilities, 30 Youth with Disabilities, and 35 iSAVE groups to government programs, including the Parish Development Model (PDM) and the National Special Grant.
- Connected 12 youth to ENABEL for specialized hospitality training.
- Linked 247 beneficiaries (136 female, 111 male) to social protection services

Economic Empowerment Transforms Lives Florence Alanyo's Story



The Economic empowerment activities under the We are Able Project are creating significant, tangible impacts in the lives of beneficiaries and their households. One such example is Florence Alanyo, Chairperson of the Nen Anyim Group.

Florence had long struggled with a land conflict involving her in-laws and her male children, which left her without secure access to land. However, through mediation efforts led by local leaders and supported by her group members, Florence successfully regained control over a significant portion of her land.

Through her consistent participation in her iSAVE saving group, Florence has made remarkable progress. She has overcome not only the land dispute but also the challenges of income and food insecurity. During the first farming season (April to August), Florence harvested an impressive 15 bags of groundnuts. Reflecting on her journey, she shared:

"I have never harvested this much since I lost my husband. I had no access to land, and most of my time was spent worrying, crying, and losing interest in anything productive around the home. I'm proud of the change in my mindset—and this harvest."

Florence plans to sell the 15 bags at UGX 170,000 each, earning a total of UGX 2,550,000 from groundnuts alone—a remarkable achievement and testament to the power of economic empowerment and mindset change.

Annet's Journey of Transformation Through the iSAVE Program

alusiba Annet, a 47- year-old woman with a physical disability, lives with her husband and five children, three boys and two girls, in Bugeye Village, Mpigi District. Before joining the iSAVE program, Annet and her family lived in isolation. They had few social connections and believed that saving money was only for the wealthy. Struggling financially, Annet was unable to meet her family's basic needs, including food, clothing, school fees, and start-up capital for any income-generating activity.

That changed in 2021 when NUDIPU introduced the iSAVE program in her community. Seeing a chance to pursue her long-standing dream of farming, Annet joined the group and accessed a loan of UGX 100,000. With it, she rented land and planted maize and beans. In her first season, she harvested one sack of maize —enough to repay the loan, support her family, and reinvest in the next planting cycle. Through determination and hard work, Annet expanded her farming activities. By the second season, her harvest had doubled to two sacks. Her involvement in the iSAVE group not only improved her household's financial stability but also helped her break social isolation, build new friendships, and participate actively in community life.

Reflecting on her journey, Annet shared in Luganda:

"Kati netaba bulungi mubyonna ebigenda mumaaso mukitundu kyange. Nsanze emikwano empiya egyigasa obulamu bwange, era ndaba obulamu bwange mu mutendera ogumu ogubuwanguzi mubiseera ebyo mumaaso."

In English:

"I now actively participate in community activities, have found new friends

who value my life, and see myself progressing to a better level in the future."

Through the iSAVE program, Annet has gained confidence, learned practical skills to address household challenges, and become a contributor to her family's well-being. Her farming business has brought a new sense of purpose and transformation, enabling her to support her husband and ensure a better future for their children.

OUR CEO AWARDED THE DIAMOND JUBILEE MEDAL BY HIS EXCELLENCY, THE PRESIDENT OF UGANDA

UDIPU extends its sincere appreciation Excellency to His Kaguta Museveni for bestowing the Diamond Jubilee Medal upon our CEO, Ms. Esther Kyozira, during the 2024 Labour Day celebrations in Fort Portal. This prestigious celebrates Ms. recognition Kvozira's exceptional dedication to advocating for the rights of persons with disabilities.

Ms. Kyozira, a visually impaired Ugandan woman, has demonstrated unwavering zeal for the disability movement since the early 2000s. Her impactful leadership includes serving as Chairperson of the National Council for Persons with Disabilities (2008-2012) and as a board member for the Higher Education Student Financing Board (HESFB) and the National Association of Women Organizations in Uganda (NAWOU) (2014-2021). Her previous role as Country

Program Officer for the Disability Rights Fund in Uganda further underscores her commitment.

A key figure in advancing disability rights in Uganda, Ms. Kyozira has been instrumental in the enactment of significant legislation such as the Persons with Disabilities Act 2020 and the Mental Health Act 2019. While serving as Program Manager for Human Rights at NUDIPU, she led the drafting and presentation of the UN Convention on the Rights of Persons with Disabilities (UNCRPD) alternative report in 2016. Currently, Ms. Kyozira continues to champion disability inclusion as a representative at the National Curriculum Development Centre and the Iudicial Council (since 2021) and as the Chief Executive Officer of the National Union of Disabled Persons of Uganda.

NUDIPU's selection of this theme highlighted its continued dedication to the inclusion of Persons with Disabilities in essential sectors. The celebrations centered on the key objectives of Advocating for Land Rights for Persons with Disabilities, Raising Awareness on Food Security for All. Increasing Awareness of the Linkages Between Gender-Based Violence (GBV) and Food Security, educating communities and stakeholders about how GBV affects food security, while promoting strategies to reduce violence and foster resilience, Fostering Partnerships among Stakeholders.

GENERAL CHALLENGES

- 1. Access to justice for inmates with disabilities remains a critical gap, highlighting a significant need for legal aid services.
- 2. Despite funding, refugee-led organizations often lack the capacity to effectively include refugees with disabilities in their programs.
- 3. The low uptake of PDM funds among Persons with disabilities is significantly hindered by a lack of National Identity Cards, insufficient awareness about the program, and concerns regarding the repayable nature of the funds.
- 4. Insufficient funding for the digital observatory system limits comprehensive profiling of persons with disabilities in their communities, impacting data accuracy and coverage.
- 5. Low literacy levels and the high cost of compatible assistive devices present significant barriers for a large proportion of persons with disabilities in utilizing ICT.
- 6. High community expectations and unrealistic demands for direct support place undue pressure on project teams and create a misalignment with available resources.
- 7. The ban on fishing silver fish in Buvuma has severely affected the livelihoods of persons with disabilities who heavily relied on this activity, consequently affecting loan recovery, group cohesion, and project sustainability.
- 8. Poor governance and internal conflicts lead to the collapse of notable iSAVE groups.
- The charity model employed by some partners, providing handouts within our operational communities, fosters dependency among beneficiaries and creates unfavorable comparisons with our project.

GENERAL RECOMMENDATIONS

- 1. There is need to support access to assistive devices for prisoners with disabilities.
- 2. More efforts required to train organizations on disability inclusive programming
- 3. Continuous advocacy for a review of PDM guidelines to improve accessibility for Persons with Disabilities.
- 4. There is need for continuous advocacy to expedite the development of an inclusive ICT policy that ensures robust data governance and enhances accessibility across all levels.
- 5. Establish continuous engagement and dialogue with Parish Development Committees to strengthen the inclusion of Persons with Disabilities in financial support programs and government interventions, ensuring resource allocation aligns with their specific needs.
- 6. There is need to conduct an accessibility assessment of financial institutions and their staff to promote inclusive practices and the implementation of reasonable accommodation measures within financial systems.
- 7. Need to enhance resource mobilization by diversifying funding sources and strengthening donor partnerships to ensure sustained financial and technical support for long-term project continuity.
- 8. Building resilience against market shocks (e.g., fish bans) and expand economic opportunities for Persons with Disabilities through initiatives such as agribusiness, crafts, retail, and vocational services.
